Dale Barclay with the HVFD requested the board to review a quote for the last airpack the fire department needs and consider purchasing it for the fire department. Discussion followed. It will be added to next months agenda for approval.

Moved by Cain and seconded by J. Barclay to pour a cement pad outside the fire hall for the generator. All members present voted Aye. Motion carried.

Moved by Eriksen and seconded by Cain to approve a variance/special exception regarding a cement pad that will lay 4 feet from the alleyway instead of the required 5 feet. Agenda noted accessory building, but after discussion, it is just a cement pad being poured in the homeowners back yard. Three members voted Aye, one member abstained. Motion carried.

Moved by A. Barclay and seconded by Cain to renew work orders for Street Superintendent and Engineering Services with Olsson. All members present voted Aye. Motion carried.

Moved by Cain and seconded by Eriksen to sign the franchise agreement with Winnebago Tribe of Nebraska Fiber Optic Installation pending attorney review and approval. All members present voted Aye. Motion carried.

Moved by Eriksen and seconded by J. Barclay to approve AMGL for FY 2025 Audit. All members present voted Aye. Motion carried.

Moved by Eriksen and seconded by A. Barclay to approve Daum Tree Service to remove dead trees and trim trees as needed on Village property throughout town. All members present voted Aye. Motion carried.

Moved by Cain and seconded by Eriksen to approve the purchase of a Bobcat mini excavator for \$35k. All members present voted Aye. Motion carried.

Discussion was held regarding a portable lift for the village truck. Maintenance to look into pouring a cement pad and install a winch or possibly fabricate a lift for the skid loader.

Moved by Cain and seconded by A. Barclay to approve sending Shane Kinzie to the next available Water and Lagoon classes to get certified. All members present voted Aye. Motion carried.

Moved by Cain and seconded by Eriksen to approve compensation for Jason Kleider with Dakota City for water testing. All members present voted Aye. Motion carried.

Moved by Eriksen and seconded by Cain to purchase new posts and gates for Lagoon entrance. All members present voted Aye. Motion carried.

There were no citizen concerns.

Board Report- Amber Barclay reported on the Dakota County Housing Trust Fund meetings she has been attending as the Village of Homer representative.

Maintenance report- Shane requested to sell the old baseball field lights, updated board on parks being winterized, spoke on September and October water loss percentages.

Clerk report- Sam gave an update regarding the audit and working with Jamie and Nancy Bryan per Jamie's recommendation.
