All members present voted aye. Motion carried. There was additional conversation regarding a tire shredding business being moved to this leased lot. The board requested the clerk to email the board members individually to see if a special meeting needs to be held to act on having a new lease written for the remainder of the term.

Discussion was held regarding the purchase of a portable lift for the village truck. Maintenance to obtain more information. Topic tabled until next meeting.

Moved by Cain and seconded by Eriksen to adjust one residents' water bill to the average amount from the month of August. Four members voted aye, one member abstained. Motion carried.

There were no citizen concerns.

The board reported on continued concerns regarding North Street and a resident's complaint regarding the water.

Maintenance report- Bruce and Shane spoke on record keeping, water testing, and meeting with the NE Rural Water.

Clerk report- Sam gave an update on FY2025 and getting Bruce and Shane signed up for classes.
